Are you applying for New or Duplicate personalized tags for a vehicle?

GENERAL INSTRUCTIONS: You must fill out this application completely in order for your application to be processed. **A non-refundable reservation fee of \$100.00 is due when the order is placed.** Please note, this fee is in addition to any registration fees. You will be notified by US mail or e-mail concerning the availability of your selections and when the tags are ready for pick-up. Please allow **approximately 6-8 weeks** from the time your application is received. The tags will be available for pick-up at our **Southwest Service Center, 95 M Street, SW** upon notification. To obtain your personalized tags you must bring the following items to the **Southwest Service Center:** your valid DC Driver License or DC Identification Card and your current tags. **YOU MUST SURRENDER YOUR CURRENT TAGS AND VEHICLE REGISTRATION CARD WHEN YOU PICK UP YOUR PERSONALIZED TAGS.** NOTE: Personalized tags are only issued for use on registered private passenger vehicles. Lost or stolen personalized tags can not be duplicated.
