To prove identity, you must show proof of the following five elements:

1 - Full Legal Name*; 2 - Date of Birth; 3 - Legal Presence in US; 4 - Social Security Number; and 5 - Ohio Street Address

To prove an element, the element must be contained on the document.

Acceptable documents that contain a current Ohio street address are acceptable to prove address.

Is your current full legal name the same as the name listed on your identity document?

If the documents presented do not prove full legal name and / or are inconsistent with your current BMV record, additional documents must be presented.

- Marriage Certificate or Marriage License**
- Certified Copy of a Decree of Divorce, Dissolution, or Annulment of Marriage**
- Certified Copy of a Court Ordered Name Change

****NOTE**: If you have had more than one marriage, you may need to bring documentation from each marriage and / or divorce to connect your birth certificate, passport or USCIS documents to your current legal name.
