

VIRGINIA VETERAN MILITARY SERVICE CERTIFICATION

Purpose: Virginia veterans include this form when applying for a veteran indicator on their Virginia license or identification card (ID).

Instructions: Include this completed DL 11 form and an acceptable veteran service proof document when submitting your Driver's License and Identification Card Application (DL 1P) or Commercial Driver's License (CDL) Application (DL 2P).

ELIGIBILITY REQUIREMENTS

To qualify for a veteran indicator on a license or ID card, the applicant must:

- be a Virginia resident,
- hold or apply for an unexpired Virginia license or ID card,
- have served in the active U. S. Armed Forces or served for more than 180 days in the Virginia National Guard or U. S. Reserves,
- received an honorable or general discharge and,
- present a veteran service proof document or combination of documents that provide branch of service, discharge date and discharge status (eg. DD-214, DD 256, WD AGO, or NGB 22). Photocopies are accepted.
