

## OREGON APPLICATION FOR MILITARY SKILLS TEST WAIVER

(Additional documents required. See Oregon Administrative Rule 735-062-0080 and/or www.oregondmv.com)

The Commercial Driver License (CDL) skills test waiver form may be used by service members who are currently licensed and who are or were employed within the previous 12 months in a military position whose **primary** duty is the operation of a military motor vehicle equivalent to a Commercial Motor Vehicle (CMV). This waiver allows a qualified service member to apply for a CDL without skills testing. **CDL knowledge (written) test(s)**, **Passenger and/or School Bus Skills test(s) cannot be waived.**
