Application for Temporary Operation Permit

RV-F1314401 (Rev. 9-18)

PURPOSE: Temporary operation permits (TOP's) may be issued to motor vehicle owners desiring to operate a vehicle otherwise subject to registration for a period of thirty (30) days when the owner is unable to obtain a new registration or renew a previous registration for the vehicle. One (1) additional TOP may be issued to such owner for a period of thirty (30) days if the owner is unable to resolve the original issue during the previous thirty (30) day period. Temporary Operation Permits shall not be issued for vehicles that have failed vehicle emissions testing. INSTRUCTIONS: Application must be made in person through the County Clerk's office. Applicants must provide proper identification (acceptable forms of identification include either: one (1) photo identification containing a distinguishing number, or two (2) other forms of identification), supporting documentation and payment of a \$10.00 fee (plus any applicable county fees). All parts of this application must be completed. Certain vehicles having stop or reject codes may not be eligible for temporary operation permits.
